The Controller of your personal data provided in the above form shall be Siemens Finance Sp. z o.o. with its registered office in Warsaw (03-821), at ul. Żupnicza 11. For all matters related to the processing of your personal data, please contact the Controller at the following e-mail address: dataprotection@siemens.com.

The Controller may process the personal data of the users of postlease.pl /poleasingowa.pl webservice (Post-Lease Webservice) for the following purposes:

- a) registration of an account at the Post-Lease Webservice and for the purpose of providing services as part of that webservice, pursuant to Article 6 (1)(b) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter referred to as “GDPR”),
- b) handling-processing of submitted bids and execute purchase transactions, pursuant to Article 6 (1)(b) of GDPR,
- c) marketing of own products and services, pursuant to Article 6 (1)(a) of GDPR,
- d) fulfilling legal obligations incumbent on the Controller pursuant to Article 6 (1)(c) of the GDPR, in particular in order to fulfil obligations arising from tax regulations, accounting regulations, customs regulations, export control regulations and regulations on counteracting money laundering and financing of terrorism,
- e) for analytical purposes and monitoring of activity in the Post-Lease Webservice, based on the legitimate interest of the Controller or third parties (art. 6 (1)(f) of the GDPR), where the legitimate interest is to conduct research and keep statistics,
- f) keeping in contact – providing information based on the legitimate interest of the Controller or third parties (art. 6 (1)(f) of the GDPR), where the legitimate interest is to ensure due customer care and answer the questions raised,
- g) establish, pursue or defend against claims, under the legitimate interest of the Controller or third parties (art. 6 (1)(f) of the GDPR), where the legitimate interest is the establishment, pursuing or defense against claims.

Personal data shall be provided to processors processing the data on behalf of the Controller, in particular, to entities providing IT-related services and signing documents on-line, however solely for the purpose and to the extent necessary to deliver the aforementioned objectives. Your personal data shall not be transferred to third countries or international organizations.

Your personal data shall be processed until the statute of limitations on possible claims or the obligation to archive data under the applicable law expire. Should you grant your consent to personal data processing for marketing purposes, your data shall be processed until the consent is withdrawn. The consent granted may be withdrawn at any time. The withdrawal of consent shall not affect the lawfulness of personal data processing based on consent granted before its withdrawal. In relation to the processing of your personal data, you also have the right to access your personal data, right of their rectification, right of their erasure, right to data portability, right of limitation on processing, and the right to object to the processing thereof. To exercise one of your rights, please contact the Controller at the address provided above.

In some cases, the Controller may use in its procedures - in connection with examination of an application for lease/loan - the so-called automated decision-making (art. 22 of GDPR) in the form of the automatic verification of creditworthiness. The aforementioned automated procedures are necessary to conclude an agreement with the Controller. Should any concerns arise in connection with the described above decision of the Controller, you have the right to question that decision, i.e. to submit a request to verify the decision made by a person duly authorized by the Controller.

The provision of personal data is voluntary; however, it is necessary to register an account at the Post-Leasing Webservice.

Your data security is a priority for us; however, if you believe that while processing your personal data we breach the provisions of GDPR, you have the right to lodge a complaint with the President of the Office for the Protection of Personal Data.
